## To Whom It May Concern: Re: Pasadena Rent Control Results

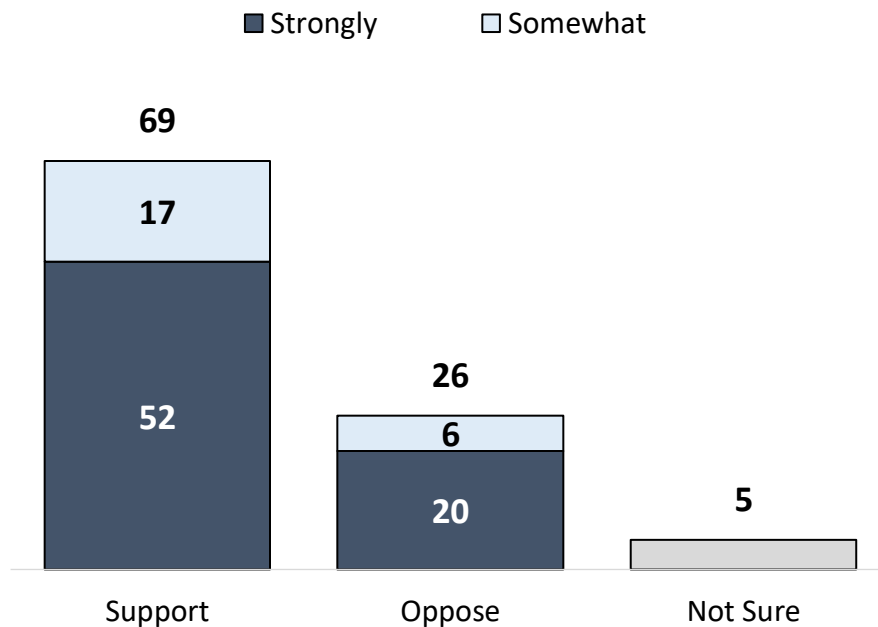
### Methodology

David Binder Research conducted a survey of 700 likely voters who voted in 11/16 or 11/18 or have registered since 11/18 with no previous election history. Interviews were conducted by telephone, with 69% of telephone interviews conducted via cell phone and 31% via landline from January 30<sup>th</sup> – February 5<sup>th</sup>, 2019. The margin of error for the survey is +/- 3.7%. The demographics of this survey reflect the accurate proportion of likely voters by ethnicity, City Council District, age, gender, and party registration.

### Topline Findings

Voters were asked to indicate their support or opposition for the city council to adopt a rent control law that would put an annual limit on the amount a landlord can raise the rent. Three-in-five (69%) voters support the city council adopting a rent control law.

**Do you support or oppose the Pasadena City Council adopting a rent control law that would put an annual limit on the amount a landlord can raise the rent?**

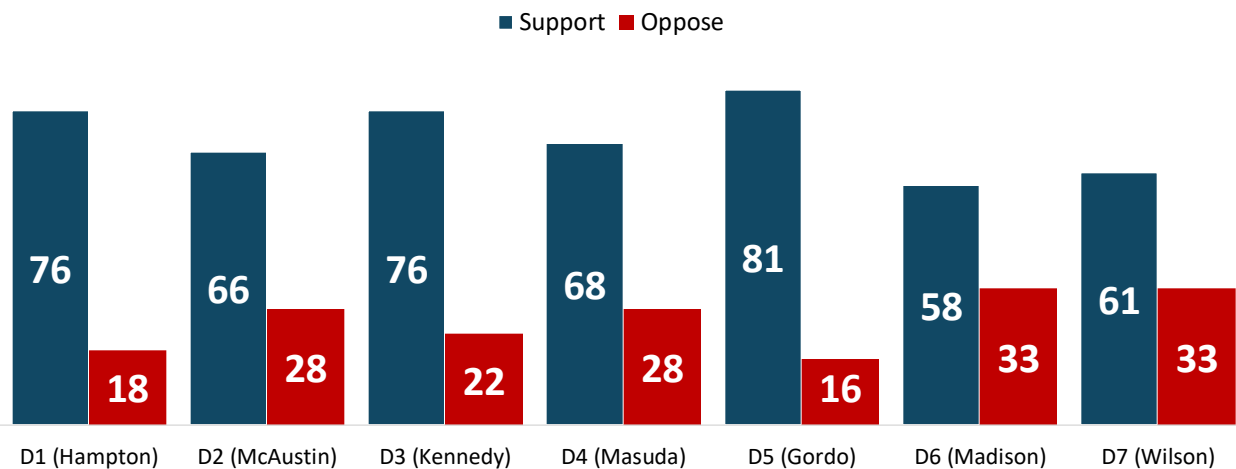


There is strong support found among all subgroups, with the exception of registered Republicans.

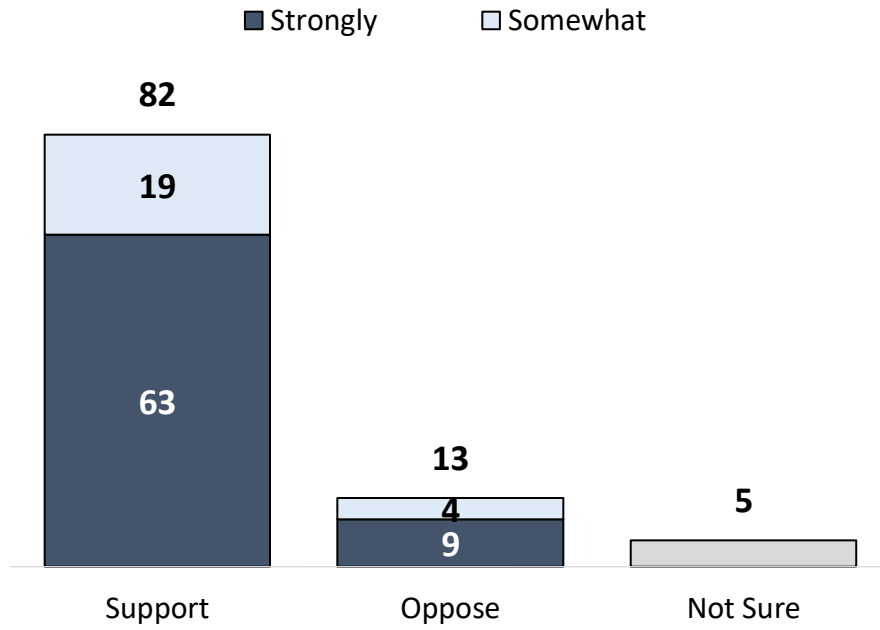

When voters were asked about a Pasadena law to prevent landlords from evicting tenants without just cause, nearly three-in-four (82%) voters indicated they support the law.

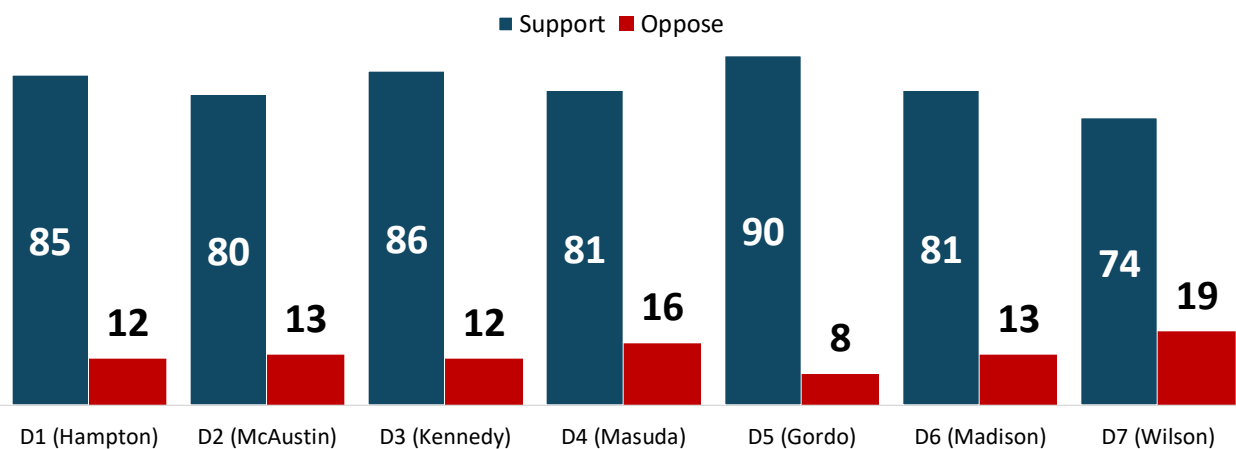


All subgroups strongly support a law to prevent landlords from evicting tenants without just cause.
